

Orphaned Heart Ministries

Orphaned Heart Ministries Worldwide (OHM) is an International, not-for-profit 501(c)(3) organization dedicated to

- (1) Educating and healing the “orphaned heart” condition in all affected persons worldwide (especially orphans, widows, and captives) through online media, clinics and conferences.
- (2) Providing financial support and economic opportunity to help OHM achieve its mission of expanding evangelism and bible distribution worldwide with an emphasis on alumni fellowship groups and house church planting that results in effective “disciple-making”.

Based in Coraopolis, Pennsylvania USA, OHM has provided over \$300,000 in funds since 2012 to participating churches in Africa for

- (a) event scholarships
- (b) study resources and books
- (c) faculty recruitment and retention
- (d) pioneering new course material for emerging and special needs populations
- (e) alumni services and
- (f) development of new online distance-learning methodologies.

Key project funds are raised by an annual Fall TV Telethon and Radio/Internet Public Service Announcements. The average ask is \$49 USD one time gift (About 13 cents a day). Each new donor receives an mp3 of the song “A New Song” or a PDF chapter from the “Healing The Orphaned Heart” book.

Future administrative budgets will be raised from:

- (1) On-going resource materials and webinar sales via eCommerce.
- (2) Ticket sales to a special event-laden Spring weekend featuring:
 - a. Friday Night Benefit Concert,
 - b. Saturday Men’s Golf Tournament/Ladies Fashion Show & luncheon,
 - c. Saturday Evening Gala and silent auction,
 - d. Sunday Morning Worship and Inspirational Brunch.

All these occur on-site at a five star resort in SWFL.

The 10 year plan calls for Orphaned Heart Ministries to touch each continent with the Healing the Orphaned Heart message by 2032. This will be achieved by utilizing Internet media that is translated into multiple major world languages.

Duplication and scaling of the efforts spearheaded by our Ugandan team are currently being tested and evaluated prior to a worldwide rollout.

OHM is seeking 3 community volunteers to serve on our Board of Directors. This role supports the organization's mission, vision, strategic goals, policies, and programs through the following:

- strategic planning
- monitoring of strategic goals to ensure success
- policy development
- financial development

The Board Member's Qualifications:

- Passionate about volunteering in the education, and spirituality/healing space.
- Possesses creative fundraising ideas and the motivation to make them happen.
- Connected to and/or interested in outreach to the local business community.
- Enjoys connecting people and finding partnership opportunities.
- Comfortable reaching out to their network of family and friends about a good cause.
- Strong communication skills, highly organized.

The Board Member's Primary Responsibilities:

1. Remain apprised of new organizational developments.
2. Read and understand OHM's financial statements and otherwise help the board fulfill its fiduciary responsibilities.
3. Attend 1 hour quarterly Zoom calls with all the other board members, ask questions, and participate in discussions. Commitment of attending one annual in-person Board meeting to be held in conjunction with the Annual Gala Celebration in the United States projected to be held in March 2023. (Travel and lodging allowance provided upon request.)
4. Play an active role in securing the financial resources necessary for OHM to achieve its mission.
5. Leverage personal relationships and connections to identify and solicit potential donors, as well as directly invest in OHM's work by making a personal contribution each year.
6. Represent OHM in the community and advocate for OHM's mission, programs, and services as appropriate.
